PROPOSITION BULLDOGS

Shall the Board of Education of the La Plata R-II School District, Missouri, borrow money in the amount of Two Million Six Hundred Thousand Dollars (\$2,600,000) for the purpose of providing funds to repair plumbing issues, renovate existing areas for additional storage, and make exterior building improvements at the Elementary School; to enhance security at entrances, complete updates in the commons area, and make exterior building improvements at the High school; to resurface the track at the sports complex; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof resulting in an estimated increase to the debt service property tax levy of \$0.5000 per one hundred dollars of assessed valuation?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to increase from \$0.0000 to \$0.5000 per one hundred dollars of assessed valuation of real and personal property.

Proposition C.A.R.E. (Community Action Reinvesting in Education)

Shall the Board of Education of the La Plata R-II School District, Missouri, be authorized to increase the operating tax levy by \$0.2500 to \$3.4190 per one hundred dollars of assessed valuation for the purposes of attracting and retaining quality certified and support staff and meeting additional operating expenses?

If this proposition is approved, the adjusted operating levy of the District is estimated to increase by \$0.2500 from \$3.1690, currently, to \$3.4190 per one hundred dollars of assessed valuation for the 2025 Tax Year and can be applied to the assessed valuation for each year thereafter.
